### **COMPLAINT**

COMES NOW the plaintiff, the State of Oklahoma ex rel. the Oklahoma State Board of Medical Licensure and Supervision (the "Board"), by and through its attorney, Elizabeth A. Scott, Assistant Attorney General, and for its Complaint against the Defendant, Stephen Paul Wolf, M.D., Oklahoma license no. 17827, alleges and states as follows:

- 1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §480 *et seq.*
- 2. Defendant, Stephen Paul Wolf, M.D., holds Oklahoma license no. 17827 and previously practiced internal medicine in Oklahoma City, Oklahoma.
- 3. On or about November 16, 2009, Defendant was arrested at his home in Oklahoma City, Oklahoma for stabbing and killing his nine (9) year old son, and stabbing and injuring his wife.
- 4. On or about November 25, 2009, Defendant was charged with MURDER IN THE FIRST DEGREE (FELONY) and ASSAULT AND BATTERY WITH A DANGEROUS WEAPON (FELONY), Case No. CF-2009-6406.
- 5. On or about June 3, 2011, Defendant was acquitted on both counts filed against him on the ground of insanity at the time of the commission of the offenses.

- 6. As a result of the Court's finding that Defendant was insane, he was immediately committed to a facility designated by the Oklahoma Department of Mental Health and Substance Abuse Services to examine and treat forensic individuals.
  - 7. Defendant is guilty of unprofessional conduct in that he:
    - A. Has been found mentally incompetent or insane by any court of competent jurisdiction in violation of OAC 435:10-7-4(16). Commitment to an institution for the insane shall be considered prima facie evidence of insanity of any physician or surgeon.
    - B. Is physically or mentally unable to practice medicine and surgery with reasonable skill and safety in violation of OAC 435:10-7-4(17).
    - C. Violated any provision of the medical practice act or the rules and regulations of the Board or of an action, stipulation, or agreement of the Board in violation of 59 O.S. §509(13) and OAC 435:10-7-4(39).
    - D. Is unable to practice medicine with reasonable skill and safety to patients ... as a result of any mental or physical condition in violation of 59 O.S. §509(15) and OAC 435:10-7-4(40).
    - E. Engaged in practice or behavior that demonstrates an incapacity or incompetence to practice medicine and surgery in violation of OAC 435:10-7-4(18).

#### Conclusion

WHEREFORE, plaintiff requests that the Board conduct a hearing, and upon proof of the allegations contained herein, impose such disciplinary action as authorized by law, up to and including the revocation or suspension of the Defendant's license to practice as a physician in the State of Oklahoma, the assessment of costs and fees incurred in this action, and any other appropriate action with respect to Defendant's license to practice as a physician in the State of Oklahoma.

YOU ARE HEREBY NOTIFIED that on the <u>D</u> day of September, 2011, a sworn Complaint was filed with the undersigned Secretary of the Oklahoma State Board of Medical Licensure and Supervision, State of Oklahoma, charging you with violations of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act at 59 Okla. Stat. §509 (13) and (15) and OAC 435:10-7-4 (16), (17) (18), (39) and (40). A copy of the Complaint is attached hereto and made a part thereof.

On November 3, 2011, the Board will be in regular session at 9:00 o'clock a.m., at its offices located at 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma, at which time your Complaint will be considered by the Board, and a hearing will be held pursuant to the Oklahoma Administrative Procedures Act, 75 Okla. Stat. §309, et seq., as amended.

If the Board decides, after considering all the testimony and evidence, that you are guilty as charged, your license to practice as a physician within the State of Oklahoma may be suspended or revoked or other disciplinary action may be taken by the Board as authorized by law, including the assessment of costs and attorney's fees for this action as provided by law.

Under the laws of the State of Oklahoma, you are required to file your written Answer under oath with the Secretary of the Board within twenty (20) days after the Citation is served upon you. Unless your Answer is so filed, you will be considered in default, and the Board may accept the allegations set forth in the complaint as true at the hearing of the complaint. If the charges are deemed sufficient by the Board, your license to practice as a physician in the State of Oklahoma may be suspended or revoked.
