## **ORDER TERMINATING PROBATION**

This cause came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on March 22, 1996, upon proper motion and fee submitted by Stanley A. Lightfoot, M.D.

The Petitioner advised the Board of the request for termination of probation earlier than prescribed at the imposition of the probation, May 9, 1992 and the Board, being advised in the premises finds and orders as follows:

#### **FINDINGS OF FACT**

- 1 That the Petitioner is the holder of Oklahoma Medical License Number 18007
- 2. That the Oklahoma Board of Medical Licensure and Supervision has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and rules of the Board.
- 3. That following notice and hearing on or around May 9, 1992, Petitioner's medical license was placed on probation immediately upon granting of said license to practice medicine and surgery in the State of Oklahoma.
- 4. That pursuant to the probation terms and conditions, restrictions were placed upon the practice of the Petitioner and have been in force and effect since the license was granted.
  - 5. That subsequent to granting of license and placement on probation to the

Board, the Petitioner has functioned in compliance with those terms and conditions since the granting of the license.

- 6. That early termination was supported by evidence from the Petitioner through oral testimony to the effect that an unrestricted license was necessary so that Petitioner could sit for an examination in a sub-specialty for specialty board certification in that sub-specialty.
- 7. That the Board of Medical Licensure and Supervision, recognizing the compliance of the Petitioner since May 9, 1992, finds that early termination of probation does not pose any danger to the public health, safety and welfare.

#### **CONCLUSIONS OF LAW**

- 1. That the Oklahoma Board of Medical Licensure and Supervision has lawful jurisdiction over this Petitioner pursuant to the Oklahoma Medical Practice Act, 59 O.S. Supp 1995, §481 et seq.
- 2. That the Board within its discretion may terminate the probation of a Petitioner for good cause shown.

#### **ORDER**

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:

- 1. That the probation of Stanley A. Lightfoot, M.D., License Number 18007 should be and is hereby TERMINATED.
- 2. That a copy of this written Order should be sent to the Petitioner as soon as possible for his records.
