**ORDER TERMINATING PROBATION**

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on September 21, 2006, at the Board office, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

William Price, M.D., holding Oklahoma medical license no. 18087, appeared in person and pro se.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

***FINDINGS OF FACT***

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
2. Dr. Price currently holds medical license no. 18087 under an indefinite term of probation that commenced on or around September 24, 1999.
3. The State has requested that Dr. Price's probation be terminated effective September 21, 2006.

4. Tom Sosbee, Compliance and Education Coordinator for the Board, testified that Dr. Price has complied with all terms of his probation and no purpose would be gained by having Dr. Price continue under probation.

5. The State has presented sufficient evidence to support the requested early termination.

**CONCLUSIONS OF LAW**

1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*

2. The State has presented satisfactory evidence to justify termination of the probationary period. The purposes of the probationary period have been accomplished. No useful purpose would be gained by having Dr. Price continue under probation.


**ORDER**

**IT IS THEREFORE ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. The State's application to terminate Dr. Price's probation is **GRANTED** and his probationary period is terminated effective September 21, 2006.

2. A copy of this written order should be sent to Dr. Price as soon as it is processed.
