### ORDER MODIFYING BOARD ORDER

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision ("Board") on September 14, 2023, at the office of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and the rules of the Board.

Gary Ricks, Compliance Coordinator for the Board, appeared on behalf of Plaintiff. Temp Ray Patterson, M.D. appeared in person. Plaintiff and Defendant are collectively referred to herein as the "Parties."

The following witnesses were sworn and testified: Temp Ray Patterson, M.D., Defendant; Bruce Meyer, M.D. with the Oklahoma Department of Corrections and Gary Ricks, Compliance Coordinator.

The Board, having heard testimony, and being fully apprised of the premises, makes the following findings of fact, conclusions of law and orders:

#### **Findings of Fact**

- 1. In Oklahoma, Defendant holds medical license no. 18099.
- 2. On May 12, 2022, an Order Granting Reinstatement of License Under Terms of Probation after SILOP was entered. (2022 Order") was filed.
- 3. On September 8, 2023, Defendant requested a modification to the 2022 Order.
- Mr. Ricks testified and recommended that Specific Term "a" of the 2022 Order be modified to provide:

Order Modifying Order: 19-11-5843 Temp Ray Patterson, MD18099 All of Defendant's prospective employment shall be related to the medical practice of otorhinolaryngology or supervised general medical practice for the Oklahoma Department of Corrections.

5. The Board concluded that Specific Term, "a" of the 2022 Order for Temp Ray Patterson, M.D. #18099 should be modified as follows:

All of Defendant's prospective employment shall be related to the medical practice of otorhinolaryngology or supervised general medical practice for the Oklahoma Department of Corrections.

6. Any conclusion of law below which is more properly characterized as a finding of fact is hereby incorporated as a finding of fact.

#### Conclusions of Law

- 7. The Board has jurisdiction over the subject matter and is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma. 59 O.S. § 480, 59 O.S. 492, and Okla. Admin. Code §§ 435:5-1-1, 435:10-4-2.
- 8. Notice was provided as required by law and the rules of the Board. 75 O.S. § 309; 59 O.S. § 504; Okla. Admin. Code §§ 435:3-3-5, 435:3-3-6.
- 9. Any finding of fact above which is more properly characterized as a conclusion of law is hereby incorporated as a conclusion of law.

#### **Orders**

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:

- 10. The Defendant's Motion to Modify is GRANTED as follows.
- 11. Effective immediately, Specific Term "a" of the 2022 Order for TEMP RAY PATTERSON, M.D. #18099 is modified as follows:

All of Defendant's prospective employment shall be related to the medical practice of otorhinolaryngology or supervised general medical practice for the Oklahoma Department of Corrections.

12. A copy of this Order shall be provided to Defendant as soon as it is processed.
