ORDER VACATING PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on June 27, 1992, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the staff of the Oklahoma Board of Medical Licensure and Supervision; and the Applicant appeared in person, and by representative, J. Darrel Smith, M.D.

The Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits and being fully advised in the premises, the Oklahoma Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Applicant, Huey Thomas Holt, Jr., holds Oklahoma Medical License No. 18123.

2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That the Applicant provided evidence that he came from a state with an established and nationally-recognized physician recovery program, and that the Applicant had achieved seven years of sobriety, and the Applicant also pledged to participate fully in the activities and recommendations of the Physician Recovery Committee of the Oklahoma State Medical Association.

4. That in light of those developments, the probation previously imposed by the Board, following notice and hearing on May 9, 1992, may be vacated without jeopardy to public health, safety and welfare.

CONCLUSIONS OF LAW

1. That the decision to vacate probation is within the sound discretion and judgment of the Board.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the probation previously imposed on May 9, 1992, following notice and hearing, against Huey Thomas Holt, Jr., holding Oklahoma Medical License No. 18123, should be and is hereby VACATED.

2. That Applicant/Defendant should receive a written copy of this Order so his file is complete.
