## **ORDER MODIFYING PROBATION**

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on May 7, 1999, at the offices of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Bryan Scott Wood, M.D., Oklahoma medical license no. 18662, appeared pro se.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact:

# FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. On September 24, 1998, Dr. Wood entered into a Voluntary Submittal to Jurisdiction under terms of probation. His license number is 18662.

3. Dr. Wood now seeks modification of his license to allow him to re-apply for state and federal registrations for Controlled Dangerous Substances. Dr. Wood makes this request based upon his obtaining of licensure and employment in the state of Kentucky.

4. Tom Sosbee, Compliance and Education Coordinator for the Board, testified that Dr. Wood had complied to date with the terms of probation.

5. Dr. Wood presented satisfactory evidence to justify modification of the terms of his probation to allow him to re-apply for state and federal registrations for Controlled Dangerous Substances.

6. Dr. Wood's probation in the State of Oklahoma will be tolled while he remains outside the State of Oklahoma.

7. All other terms of Dr. Wood's probation remain in full force and effect.

#### CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 481 et seq.

2. Dr. Wood has presented satisfactory evidence to justify modification of the terms of his probation to allow him to re-apply for state and federal registrations for Controlled Dangerous Substances.

#### ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Dr.Wood's application to modify the terms of his probation is GRANTED.

2. The terms of Dr.Wood's probation are MODIFIED to allow him to re-apply for state and federal registrations for Controlled Dangerous Substances.

3. Except as expressly modified in this order, all other terms and conditions of the Voluntary Submittal to Jurisdiction entered on September 24, 1998 shall remain in full force and effect until further modified or terminated by Board order upon its own motion or pursuant to motion of Dr. Wood. Dr. Wood's probation in the State of Oklahoma will be tolled while he remains outside the State of Oklahoma.

4. A copy of this written order shall be sent to Dr. Wood as soon as it is processed.
