**ORDER APPROVING APPLICATION FOR  
MODIFICATION OF SPECIAL MEDICAL LICENSE**

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on January 27, 2005, at the Board office, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant, Francois J. du Toit, appeared, *pro se*, before the Board, thereby waiving his right to legal counsel.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

***FINDINGS OF FACT***

1. Applicant applied for modification of his special medical license in Oklahoma as a physician and surgeon so as to allow him to enter the Southwest Oklahoma Family Practice Residency Program in Lawton, Oklahoma.
2. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.
3. The Applicant was able to present sufficient evidence that his special medical license should be modified to allow him to enter the Southwest Oklahoma Family Practice Residency Program.

**CONCLUSIONS OF LAW**


- 1 The Board has jurisdiction to hear this matter pursuant to 59 Okla. Stat. §480 *et seq.*
2. The Applicant was able to present sufficient evidence that his special medical license should be modified to allow him to enter the Southwest Oklahoma Family Practice Residency Program.

**ORDER**

**IT IS THEREFORE ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. The application of Francois J. du Toit, application number 19144, for modification of his special medical license in the State of Oklahoma is **GRANTED**.
