ORDER MODIFYING PROBATION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on May 5, 2005, at the Board office, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant, Steven Ross Mareburger, M.D., holding probated Oklahoma medical license no. 19224, appeared in person without counsel, thereby waiving his right to legal representation.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
2. Dr. Mareburger currently holds Oklahoma medical license no. 19224 under a five (5) year term of probation which began January 17, 2002.
3. On May 5, 2005, Dr. Mareburger requested that the terms of his probation be modified to allow him to attend three (3) 12-Step meetings per week, as opposed to five (5) meetings per week as is currently required under his January 17, 2002 Order Accepting Voluntary Submittal to Jurisdiction.
4. Dr. Mareburger presented sufficient evidence to support the requested modifications.

CONCLUSIONS OF LAW


- 1 The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*
- 2 Dr. Mareburger has presented satisfactory evidence to justify allowing him to attend three (3) 12-Step meetings per week, as opposed to five (5) meetings per week as is currently required under his January 17, 2002 Order Accepting Voluntary Submittal to Jurisdiction.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Dr. Mareburger's application to modify the terms of his probation is **GRANTED**.
2. Dr. Mareburger's probation shall continue from January 17, 2002 for a period of five (5) years under the terms and conditions set forth in the January 17, 2002 Order, with the exception that Dr. Mareburger be allowed to attend three (3) 12-Step meetings per week, as opposed to five (5) meetings per week as is currently required under his January 17, 2002 Order Accepting Voluntary Submittal to Jurisdiction.
3. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Mareburger's medical license, after additional notice and hearing as required by law.
4. A copy of this written order should be sent to Dr. Mareburger as soon as it is processed.


