ORDER TABLING REINSTATEMENT APPLICATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on January 26, 2006, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Applicant did not appear before the Board.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact:

FINDINGS OF FACT

- 1. Applicant applied for reinstatement of his license in Oklahoma as a physician and surgeon.
- 2. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.
- 3. Applicant was unable to appear at this time and requested that his application be tabled until he requests that the Board consider the matter.
- 4. Applicant's request for reinstatement of his license should be tabled without further consideration until Applicant makes a personal appearance before the Board and requests consideration.

CONCLUSIONS OF LAW

1. The Board has legal authority to table an application when evidence on the

application is insufficient to allow evaluation by the Board to make a final judgment as to whether the Applicant fulfills the requirements of 59 Okla. Stat. §481 *et seq.*, and the applicable rules of the Board to qualify for licensure in Oklahoma as a physician and surgeon.

ORDER

It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows:

- 1. The application of Lee Edward Brown for reinstatement of his license in Oklahoma as a physician and surgeon should be **TABLED**.
- 2. The Board will make no further consideration on this application until Lee Edward Brown makes a personal appearance before the Board and requests that his application be considered.
- 3. A copy of this written order should be sent to the Applicant as soon as it is processed.
