## ORDER GRANTING SECOND APPLICATION FOR UNRESTRICTED OKLAHOMA MEDICAL LICENSE AFTER PRIOR REVOCATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision ("Board") on June 23, 2016, at the Board office, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and rules of the Board.

Jeffrey H. Schimandle, M.D. ("Defendant") appeared in person. Daniel J. Gamino, of Daniel J. Gamino & Associates, P.C. appeared in support of Defendant.

Joseph L. Ashbaker, Assistant Attorney General, appeared on behalf of the State.

The Board *en banc* heard testimony, reviewed the exhibits presented, and being fully apprised of the premises, **GRANTED** the Second Application for Unrestricted Oklahoma Medical License of Defendant.

## History

- 1. The Defendant holds Oklahoma Medical License No. 19233.
- 2. On February 28, 2003, Dr. Schimandle's license was revoked. The Board DENIED Dr. Schimandle's applications for reinstatement on June 25, 2004, May 21, 2009, and May 20, 2010.

- 3. On November 8, 2012, the Board issued an Order Granting Reinstatement of License With Restrictions After Prior Revocation, including:
  - C. "That Dr. Schimandle shall only be allowed surgical privileges upon satisfactory completion of a one-year ACGME approved Spine Surgery Fellowship."
- 4. On January 16, 2014, Defendant requested that the restriction on his license requiring satisfactory completion of a one-year ACGME approved Spine Surgery Fellowship in order to be allowed surgical privileges be modified. Due to the fact that ACGME does not accredit fellowships, Defendant asked that he be allowed surgical privileges upon satisfactory completion of a one-year orthopedic fellowship. Defendant's request was GRANTED, modifying paragraph 1 C of the Order Granting Reinstatement of License With Restrictions After Prior Revocation, as follows:

"Dr. Schimandle shall only be allowed surgical privileges upon satisfactory completion of a one-year orthopedic fellowship."

This condition shall remain in effective until Dr. Schimandle appears before the Board to show proof of satisfactory completion of a oneyear orthopedic fellowship.

- 5. On September 24, 2015, Defendant appeared before the Board and provided information as to his activities since the January 16, 2014 Board meeting, requesting removal of the restrictions on his medical license. Defendant's request was DENIED by the Board pending completion of six (6) months of orthopedic fellowship.
- 6. On June 23, 2016, the Defendant appeared before the Board and presented evidence showing he has satisfactorily completed one-year of orthopedic fellowship.

The Board *en banc* being fully apprised of the premises, and for good cause shown, orders as follows:

- 1. Defendants' Second Application for Unrestricted Oklahoma Medical License is **GRANTED**.
- 2. Promptly upon receipt of an invoice, Defendant shall pay all costs of this action authorized by law, including without limitation, legal fees and costs, investigation costs, staff time, salary and travel expenses, witness fees and attorney's fees.
  - 3. A copy of this written order shall be sent to Defendant as soon as it is processed.
