SECOND ORDER MODIFYING PROBATION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on September 15, 2011, at the Board office, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant, Todd Scott Redding, M.D., holding Oklahoma medical license no. 19387, appeared in person without counsel, thereby waiving his right to legal representation.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. Dr. Redding currently holds medical license no. 19387 under an indefinite term of probation that commenced January 17, 2008.

3. On March 11, 2010, Dr. Redding requested that the terms of his probation be modified to allow him to prescribe controlled dangerous drugs in Schedules IV through V. The Board granted Dr. Redding's request.

4. On September 15, 2011, Dr. Redding requested that the terms of his probation be modified to allow him to prescribe controlled dangerous drugs in Schedules III and II, with the Schedule II prescriptions limited to prescribing methadone in an opiate treatment program setting.

5. Dr. Redding presented sufficient evidence to support the requested modification.

CONCLUSIONS OF LAW


1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*
2. Dr. Redding has presented satisfactory evidence to justify allowing him to prescribe controlled dangerous drugs in Schedules III and II, with the Schedule II prescriptions limited to prescribing methadone in an opiate treatment program setting.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:


1. Dr. Redding's application to modify the terms of his probation is **GRANTED**.
2. Dr. Redding's probation shall continue indefinitely from the date of its commencement of January 17, 2008 under the terms and conditions set forth in the January 17, 2008 Order and the March 11, 2010 Order Modifying Probation, with the exception that Dr. Redding be allowed to prescribe controlled dangerous drugs in Schedules III and II, with the Schedule II prescriptions limited to prescribing methadone in an opiate treatment program setting.
3. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Redding's medical license, after additional notice and hearing as required by law.
4. A copy of this written order should be sent to Dr. Redding as soon as it is processed.
