#### **ORDER OF REVOCATION**

On the <u>13<sup>th</sup></u> day of <u>January</u>, 1997, this cause came on before the Oklahoma State Board of Medical Licensure and Supervision pursuant to notice given as required by laws and rules of the state governing Individual Proceedings.

The State of Oklahoma was represented by Daniel J. Gamino, Attorney at Law. The Defendant was not present and not represented by counsel.

The Board of Medical Licensure and Supervision heard statements by counsel, reviewed evidence submitted and heard testimony given. Being fully advised in the premises, the Board finds and orders as follows:

### **FINDINGS OF FACT**

- 1. That the Defendant, Shannon Paul Thompson, M.D., holds Oklahoma Medical License number 19506.
- That an emergency order was issued by the Secretary of the Board, pursuant to 59 O.S. Supp 1995 §503.1, on December 20, 1996, temporarily suspending Oklahoma Medical License number 19506 until hearing by the Board en banc could be convened.
- 3. That the Defendant, Shannon Paul Thompson, M.D., was given due notice of said hearing and was not present in person or by representative.

4. That the allegations contained in the complaint are found to be true by clear and convincing evidence and testimony.

#### **CONCLUSIONS OF LAW**

- 1. The Defendant, Shannon Paul Thompson is in violation of the Oklahoma Medical Practice Act, 59 O.S. §509, to-wit:
  - (16) The inability to practice medicine with reasonable skill and safety to patients by reason of age, illness, drunkeness, excessive use of drugs, narcotics, chemicals, or any other type of material or as a result of any mental or physical condition.
- 2. The Defendant, Shannon Paul Thompson is in violation of the Oklahoma Administrative Code 435:10-7-4, to-wit:
  - (17) Being physically or mentally unable to practice medicine and surgery with reasonable skill and safety.
  - (18) Practice or other behavior that demonstrates an incapacity or incompetence to practice medicine and surgery
  - (40) The inability to practice medicine and surgery with reasonable skill and safety to patients by reason of age, illness, drunkeness, excessive use of drugs, narcotics, chemicals, or any other type of material or as a result of any mental or physical condition.

#### <u>ORDER</u>

THEREFORE, it is the Order of the Board of Medical Licensure and Supervision that the Oklahoma Medical License, Number 19506, issued to Shannon Paul Thompson, should be and is hereby REVOKED.
