ORDER DENYING MODIFICATION OF PROBATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on May 5, 2005, at the Board's office, 5104 North Francis, Suite C, Oklahoma City, Oklahoma 73118, pursuant to notice given as required by law and rules of the Board.

Leslie Ann Sibley, M.D., appeared in person and through counsel, Malinda S. Matlock.

The Board *en banc* heard testimony, reviewed the exhibits presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

Findings of Fact

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
2. Dr. Sibley currently holds medical license no. 21537 under a five (5) year term of probation that commenced on July 29, 2004.
3. On May 5, 2005, Dr. Sibley requested that the terms of her probation be modified to allow her to practice at a skin care clinic as the only practicing physician at the clinic, and to apply for her permits for state and federal controlled dangerous substances.
4. The proposed modifications to Dr. Sibley's probation do not afford sufficient practice limitations or controls to assure that Dr. Sibley can practice medicine with reasonable skill and safety.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear requests for modification of licenses under 59 Okla. Stat. §480 *et seq.*
2. The Board may impose practice parameters and other restrictions as necessary to protect the health, safety and welfare of the public under 59 Okla. Stat. §480 *et seq.*


ORDER

2. A copy of this written order shall be sent to Dr. Sibley as soon as it is processed.


