ORDER GRANTING MODIFICATION TO SPECIAL LICENSE

This cause came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision ("Board") on July 14, 2016, at the office of the Board, 101 N.E. 51st Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and rules of the Board.

Yi Huang, M.D. ("Dr. Huang") appeared in person, *Pro se*. Dr. James W. Long, MD, PhD, Director, Integris Advanced Cardiac Care Program and the Nazih Zuhdi Transplant Institute, and also, Director, IH system-wide Cardiothoracic Surgery, Oklahoma City, OK, appeared in support of Dr. Huang.

Teresa Mitchell, Director of Licensing, appeared on behalf of the Board.

The Board *en banc* heard testimony of witnesses, reviewed the exhibits presented, and being fully apprised of the premises, finds and orders as follows:

Findings of Fact

- 1. Dr. Huang holds Special License number 21637, which was issued on June 23, 2000 and is scheduled to expire on June 1, 2017.
- 2. Dr. Huang is currently a United Network of Organ Sharing (UNOS) certified Organ Procurement Surgeon, practicing at the Integris Advanced Cardiac Care Program under the Institutional supervision of the Nazih Zuhdi Transplant Institute at INTEGRIS Baptist Medical Center.
- 3. On July 8, 2016 Dr. Huang sent a letter to the Board requesting clarification as to the scope of services authorized by his, June 2000 issued, Special License ("Motion").
- 4. At the July 14, 2016 Board meeting, the Ms. Mitchell presented Dr. Huang's Motion. The following two exhibits were distributed: (1) Dr. Yi Huang's letter to the Board dated July 8, 2016 re: Yi Huang, M.D. request for clarification of special license privilege, and (2) Dr. James W. Long, MD, PhD and Sudhir Khanna, MD, FRCP, letter to the Board dated July 14, 2016 re: Clarification of Special Medical Licensing for Dr. Yi Huang.

Specifically, Exhibit #2 requests as follows:

"On behalf of Dr. Yi Huang, we are requesting clarification of the language used to describe the scope of practice of the 'Medical Doctor – Special License' granted to Dr. Yi Huang, MD by the Oklahoma Medical Board (OMB) for the restricted purpose of 'Organ Procurement and Related Services' under the Institutional supervision of the Nazih Zuhdi Transplant Institute (NZTI) at INTEGRIS Baptist Medical Center (IBMC)."

- 5. The Board concluded that Dr. Huang's Motion is **APPROVED**. The Special License of Dr. Huang will modified for the purposes of clarification as to the scope of services authorized by his Special License as follows:
 - Dr. Yi Huang has been approved for 'Medical Doctor Special License' restricted to the practice of 'Organ Procurement and Related Services' including assisting Transplant Surgeons and Physicians, under their supervision, within the Institutional oversight of the Nazih Zuhdi Transplant Institute (NZTI) at INTEGRIS Baptist Medical Center (IBMC).

Conclusions of Law

- 1. The Board has jurisdiction over the subject matter and is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians, surgeons and other allied health professionals in the State of Oklahoma pursuant to 59 O.S., 2011, § 480 et seq. Notice was given as required by law and the rules of the Board.
- 2. The Board, therefore, has authority over the licensee and subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act ("Act") and its applicable regulations. The Board is authorized to enforce the Act as necessary to protect the public health, safety and welfare. 59 O.S. 2011, § 480 et seq.
- 3. The Board is authorized to issue a Special License under Okla. Admin. Code § 435:10-11-3.1. The Special License is issued pursuant to 59 O.S., 1994, § 493.4 et seq.; Okla. Admin. Code §§ 435:10-11-1; 435:10-11-3 et seq., 435:10-11-4, 435:10-11-5(b); 435:10-11-6.
- 4. Dr. Huang presented sufficient evidence and good cause to support the requested modification to his Special License.

Orders

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Dr. Huang's Motion for clarification as to the scope of services authorized by his Special License is **GRANTED**.

2. Effective July 14, 2016, the Special License of YI HUANG, M.D. is modified as follows.

Dr. Yi Huang has been approved for 'Medical Doctor – Special License' restricted to the practice of 'Organ Procurement and Related Services' including assisting Transplant Surgeons and Physicians, under their supervision, within the Institutional oversight of the Nazih Zuhdi Transplant Institute (NZTI) at INTEGRIS Baptist Medical Center (IBMC).

3. A copy of this written order shall be sent to Dr. Huang as soon as it is processed.
