FINAL ORDER GRANTING FULL MEDICAL LICENSE <u>UNDER TERMS OF PROBATION</u>

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on July 18, 2002, at the Board office, 5104 North Francis, Suite C, Oklahoma City, Oklahoma 73118, pursuant to notice given as required by law and rules of the Board.

Ardry Lance Yarbrough, Applicant, appeared in person, pro se, thereby waiving his right to legal counsel.

The Board *en banc* heard testimony, reviewed the exhibits presented, and being fully apprised of the premises, entered the following Findings of Fact, Conclusions of Law, and Orders:

Findings of Fact

Applicant currently holds Oklahoma special training license no. 22046.

2. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

3. On August 2, 2001, after due notice and hearing, the Board issued Applicant a special training license under an Order Granting Reinstatement of License Under Terms of Probation based upon a history of substance abuse.

4. The Applicant requests a full medical license under the same terms of probation applicable to his special training license with the exception that his practice not be limited to the

University of Oklahoma Health Sciences Center, Caney Valley Medical Center in Ramona, Oklahoma.

5. The Applicant presented sufficient evidence to support his application for full licensure with the requested modification to his Order Granting Reinstatement of License Under Terms of Probation.

CONCLUSIONS OF LAW

1 The Board has jurisdiction to hear this matter pursuant to 59 O.S. §480 et seq.

2. Applicant has presented satisfactory evidence to justify issuing him a full medical license and to allow the modification to his Order Granting Reinstatement of License Under Terms of Probation to allow him to practice outside the University of Oklahoma Health Sciences Center, Caney Valley Medical Center in Ramona, Oklahoma, with the restriction that any moonlighting is limited to the emergency room program and subject to review by his program director.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1 Applicant shall be ISSUED A FULL MEDICAL LICENSE.

2. Applicant's full medical license shall be issued under the same terms as set forth in the Order Granting Reinstatement of License Under Terms of Probation entered into on July 20, 2001, with the exception that Applicant be allowed to practice outside the University of Oklahoma Health Sciences Center, Caney Valley Medical Center in Ramona, Oklahoma, with the restriction that any moonlighting is limited to the emergency room program and subject to review by his program director.

3. This Order shall be effective July 18, 2002.
