ORDER DENYING TERMS OF PROBATION OR ALTERNATIVELY TERMINATING CLINICAL RESTRICTIONS FROM PROBATIONARY TERMS

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on September 18, 2014, at the Board office, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Defendant, Robert Michael Holbrook, M.D., holding Oklahoma medical license no. 22135, appeared with counsel, Chris Condren. Joseph Ashbaker, Assistant Attorney General, appeared on behalf of the State.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

Findings of Fact

- 1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
- 2. Dr. Holbrook currently holds medical license no. 22135 under terms of a two-year probation commencing on September 12, 2013.
- 3. On August 26, 2014, Dr. Holbrook requested that his probation be terminated or, alternatively, that the clinical restrictions contained in his probation be terminated.

Conclusions of Law

- 1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 et seq.
- 2. Defendant did not present sufficient evidence to justify the termination of his probation or, alternatively, terminate the clinical restrictions from his probationary terms.

<u>Order</u>

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

- 1. Dr. Holbrook's Motion to Terminate Probation or Alternatively Terminate Clinical Restrictions from Probationary Terms is **DENIED**.
- 2. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Holbrook's medical license, after additional notice and hearing as required by law.
- 3. A copy of this written order should be sent to Dr. Holbrook as soon as it is processed.
