- I, Zachariah Jessic Anderson, M.D. ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:
- 1. I hereby voluntarily surrender my Oklahoma medical license no. 22198.
- 2. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
- 3. I am currently licensed to practice medicine in the State of Oklahoma and have violated the laws and rules governing the practice of medicine with this state. Further, in a hearing on this matter the allegations, if proven, would constitute grounds for disciplinary action by the Oklahoma State Board of Medical Licensure and Supervision ("Board").
- On January 12, 2012, the Board issued an Order Accepting Voluntary Submittal to 4. Jurisdiction which Order contained the following condition:
 - J. Defendant will have the affirmative duty not to ingest any substance, including but not limited to alcohol, which will cause a body fluid sample to test positive for prohibited substances.

- The allegations of unprofessional conduct to which I plead guilty are as follows:
 On or about July 21, 2018, I consumed alcohol in violation of my probation.
- 6. I am guilty of unprofessional conduct by violating the following rules of professional conduct:

Violation of any provision of the medical practice act or the rules and regulations of the Board or of an action, stipulation, or agreement of the Board. 59 O.S. § 509(13) and Okla. Admin. Code § 435:10-7-4(39).

- 7. I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license.
- 8. I hereby agree that I will not reapply for reinstatement of my license for a minimum of one (1) year from the date this surrender is accepted by the Board. If the Board ever reinstates my license, I agree that it will be under terms of indefinite probation to be set by the Board at the time of reinstatement and that I will be required to be evaluated by Board approved providers to ensure my ability to practice safely.
- 9. If the Board does not accept this Voluntary Surrender In Lieu of Prosecution or it is disapproved by the Oklahoma Attorney General, the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against him in a subsequent disciplinary hearing. Defendant will be free to defend himself, and no inferences will be made from his willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
- 10. As a condition to accepting my voluntary surrender of license in lieu of prosecution, I acknowledge that the Board shall require me to pay all costs expended by the Board for any legal fees and cost, any investigation, probation and monitoring fees, including but not limited to staff time, salary and travel expense, witness fees and attorney fees.
