

I, Lyle R. Kelsey, Executive Director of the Oklahoma State Board of Medical Licensure and Supervision, hereby **SUMMARILY SUSPEND** the medical license of **FRANCISCO JOSE SAYAGO**, Oklahoma Medical License No. 22615.

This Summary Suspension is based upon Dr. Sayago's August 2, 2006 conviction for Possession of a Controlled Substance in Kiowa County, State of Oklahoma, his incarceration at the Lexington Assessment and Reception Center in Lexington, Oklahoma beginning August 22, 2006 and continuing for a period of three (3) years, and the authority granted to me pursuant to 59 O.S. §506(B).

A Complaint and Citation against Dr. Sayago will be heard by the Oklahoma State Board of Medical Licensure and Supervision at the November 2-4, 2006 Board meeting.
