ORDER MODIFYING PROBATION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on March 26, 2009, at the Board office, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Mark Edward Reiheld, M.D., holding Oklahoma medical license no. 23029, appeared not.

Elizabeth A. Scott, Assistant Attorney General, appeared on behalf of the State of Oklahoma.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. Dr. Reiheld currently holds medical license no. 23029 under an indefinite term of probation that commenced January 17, 2008.

3. On March 26, 2009, Board staff, on behalf of Dr. Reiheld, requested that the terms of his probation be modified to delete the requirements that he practice under the direct

supervision of a physician licensed by the Board and that he submit quarterly reports from his supervising physician to the Board Secretary for his review.

4. Board staff presented sufficient evidence to support the requested modification.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*
2. Board staff has presented satisfactory evidence to justify modifying the terms of Dr. Reiheld's probation to delete the requirements that he practice under the direct supervision of a physician licensed by the Board and that he submit quarterly reports from his supervising physician to the Board Secretary for his review.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:


1. Board staff's application to modify the terms of Dr. Reiheld's probation is **GRANTED**.

2. Dr. Reiheld's probation shall continue indefinitely from the date of its commencement of January 17, 2008 under the terms and conditions set forth in the January 17, 2008 Order, with the exception that Dr. Reiheld is no longer required to practice under the direct supervision of a physician licensed by the Board and he is no longer required to submit quarterly reports from his supervising physician to the Board Secretary for his review.

3. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Reiheld's medical license, after additional notice and hearing as required by law.

4. A copy of this written order should be sent to Dr. Reiheld as soon as it is processed.


