ORDER MODIFYING FINAL ORDER OF SUSPENSION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on June 25, 2004, at the Board office, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Elizabeth A. Scott, Assistant Attorney General, appeared for the plaintiff. Applicant, John Matthew Navarro, M.D., holding Oklahoma medical license no. 23253, appeared not.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. On or about March 25, 2004, the Board entered a Final Order of Suspension whereby Dr. Navarro's license was suspended for three (3) months followed by probation for a period of five (5) years. The Board additionally ordered that Dr. Navarro attend a seminar approved in advance by the Board Secretary for a minimum of ten (10) hours on ethics during the period of suspension.

3. On June 25, 2004, Dr. Navarro requested that that the terms of his order be modified to allow him to complete his ethics seminar in September 2004.

4. Dr. Navarro presented sufficient evidence to support the requested modification.

CONCLUSIONS OF LAW

The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 et seq.

2. Dr. Navarro has presented satisfactory evidence to justify modifying the terms of his order to allow him to complete his ethics seminar in September 2004.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Dr. Navarro's application to modify the terms of his Final Order of Suspension is **GRANTED**.

2. Dr. Navarro's Final Order of Suspension shall continue from the date of its commencement of March 25, 2004 under the terms and conditions set forth in the March 25, 2004 Order, with the exception that Dr. Navarro is allowed to complete his ethics seminar in September 2004.

3. Failure to meet any of the terms of this Order will be grounds for the Board to initiate proceedings to suspend or revoke Dr. Navarro's medical license, after additional notice and hearing as required by law.

4. A copy of this written order should be sent to Dr. Navarro as soon as it is processed.
