YOU ARE HEREBY NOTIFIED that on 16 day of December, 2011, an Application to Determine Emergency was filed by the State seeking to declare that an emergency suspension hearing was imperative for the public health, safety and welfare. The undersigned Secretary of the Board has determined that an emergency exists so as to justify an emergency suspension hearing on your license. On December 21, 2011, the Board Secretary will hold an emergency suspension hearing at 1:00 o'clock p.m., at the offices of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma, at which time a hearing will be held pursuant to the Oklahoma Administrative Procedures Act, 75 O.S. 1971, Sec. 314. If the Secretary decides, after considering all the testimony and evidence, that there has been a showing by clear and convincing evidence of unprofessional conduct for which the immediate suspension of your license is imperative for the public health, safety and welfare, your license to practice as a physician within the State of Oklahoma will be suspended pending proceedings before the Board *en banc* on all of the Counts in the Complaint.

THEREFORE, you are cited to appear at the hearing described above. If you are not present in person, you may be present through your attorney.


