## ORDER OF CONTINUANCE AND NOTICE OF HEARING

- 2. On January 26, 2023, an Immediate Suspension and Motion to Enforce were filed by the Board. Hearing for both the Immediate Suspension and the Motion to Enforce was set for March 16, 2023.
- 3. The Parties have since conferred and hereby request a continuance of both the Immediate Suspension and Motion to Enforce to the May 11, 2023, Board meeting.
- 4. This request for continuance is not being made for purposes of delay, making the continuance reasonable and in the interest of justice.
- 5. The Board finds that the ends of justice served by granting of such continuance outweigh the best interest of the public and the Defendant in a speedy hearing, and continuance is **GRANTED**, to the May 11, 2023, Board meeting.
