VOLUNTARY SURRENDER OF LICENSE IN LIEU OF PROSECUTION

I, Brian Keith Rich, Medical Doctor, ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:

- I hereby voluntarily surrender my Oklahoma Medical Doctor License No. MD 24887 effective January 18, 2024. 59 O.S. 509.1(E), et seq.
- The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
- 3. I admit that I am the subject of a proceeding by the Oklahoma State Board of Medical Licensure and Supervision ("Board") involving allegations which, if proven, would constitute grounds for disciplinary action by the Board.
- In a hearing on the matter, the allegations, if proven, would constitute grounds for disciplinary action by the Board.
- 5. I am guilty of unprofessional conduct by violating the following rules of professional conduct:
 - A. Negligence in the practice of medicine and surgery, in violation of Okla. Admin. Code § 435:10-7-4(15)..
 - B. All advertising of medical business in which statements are made which are grossly

untrue or improbable and calculated to mislead the public, in violation of 59 O.S.

§509(6) and Okla. Admin. Code § 435:10-7-4(11).

 I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license. 59 O.S. § 509(E)(2).

- 8. I hereby agree that I will not reapply for reinstatement of my Oklahoma Medical Doctor license for a minimum of one (1) year from the date this Voluntary Surrender in Lieu of Prosecution ("SILOP") is accepted by the Board. If I ever request reinstatement of my Oklahoma Medical License, I understand that I will be required to appear before and get Board approval prior to being reinstated and any such reinstatement, if granted, will be under terms and conditions of probation. I also understand I will not be eligible for reinstatement until all monies currently owed to the Board for my disciplinary matters are paid per 59 O.S. § 508.2(A) and only after a minimum of one year has passed from the date of this Order per 59 O.S. § 509.1(E)(4).
- 9. If the Board does not accept this Voluntary Surrender In Lieu of Prosecution the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against Defendant in a subsequent disciplinary hearing. Defendant will be free to defend herself, and no inferences will be made from her willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
- 10. As a condition to accepting my voluntary surrender of license in lieu of prosecution, I acknowledge that the Board shall require me to pay all costs expended by the Board for any legal fees and cost, any investigation, including but not limited to staff time, salary and travel expense, witness fees and attorney fees.
