ORDER OF CONTINUANCE

- 4. Defendant has an Agreement not to Practice with the Board and, therefore, Board staff has no objection to this continuance.
- For good cause shown, Defendant's request for continuance is hereby granted and Defendant will make an appearance before the Board at its meeting scheduled for July 17, 2014.
