## ORDER TABLING REQUEST TO SUPERVISE TWO ADDITIONAL ADVANCED PRACTICE REGISTERED NURSES

This matter came on for consideration before the Oklahoma State Board of Medical Licensure and Supervision ("Board") on November 2, 2017, at the office of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and the rules of the Board. Christopher Orendorff, M.D., appeared not.
