VOLUNTARY SURRENDER OF LICENSE IN LIEU OF PROSECUTION

I, DAVID PATRICK MURRAY, M.D. ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:

1. I am DAVID PATRICK MURRAY, M.D., holding Oklahoma Medical License No. 34855.
2. I hereby voluntarily surrender my Oklahoma medical license No. 34855, effective May 11, 2023. 59 O.S. 509.1(E), *et seq.*
3. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
4. I admit that I am the subject of a proceeding by the Oklahoma State Board of Medical Licensure and Supervision ("Board") involving allegations which, if proven, would constitute grounds for disciplinary action by the Board.
5. On September 6, 2021, I was involved in a car accident while in Arizona. I was transported to the hospital and subsequently tested positive for cocaine, amphetamines, narcotics and marijuana. On September 22, 2021, Board investigator Robbin Roberts requested, and eventually, At the time of this incident, I was under contract with OHPP. I subsequently relapsed but did not immediately inform OHPP staff.

6. I am guilty of unprofessional conduct by violating the following rules of professional conduct:
  - a. Habitual intemperance or the habitual use of habit-forming drugs, in violation of 59 O.S. § 509(4) & Okla. Admin. Code § 435:10-7-4(3)
  - b. The inability to practice medicine with reasonable skill and safety to patients by reason of age, illness, drunkenness, excessive use of drugs, narcotics, chemicals, or any other type of material or as a result of any mental or physical condition in violation of OAC 435:10-7-4(15):
7. I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license. 59 O.S. § 509(E)(2).
8. If I ever request reinstatement of my Oklahoma Medical License, I understand that I will be required to appear before and get Board approval prior to being reinstated. I also understand I will not be eligible for reinstatement until all monies currently owed to the Board for my disciplinary matters are paid per 59 O.S. § 509.2(A) and only after a minimum of one year has passed from the date of this Order per 59 O.S. § 509.1(E)(4).
9. It is further understood that I will not be eligible for reinstatement until and unless I have undergone a clinical skills assessment and been deemed safe to practice by a Board approved facility and that my license, upon reinstatement, will be under terms and conditions of probation, the terms and conditions of which to be determined at the time of reinstatement.
10. If the Board does not accept this Voluntary Surrender In Lieu of Prosecution the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against him in a subsequent disciplinary hearing. Defendant will be free to defend himself, and no inferences will be made from his willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
11. As a condition to accepting my voluntary surrender of license in lieu of prosecution, I acknowledge that the Board shall require me to pay all costs expended by the Board for any legal fees and cost, any investigation, probation and monitoring fees, including but not limited to staff time, salary and travel expense, witness fees and attorney fees.

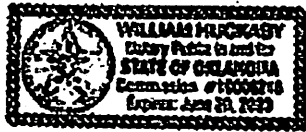
