YOU ARE HEREBY NOTIFIED that on the 14th day of March 2024, a Verified Complaint was filed with the undersigned Board Secretary of the State of Oklahoma, *ex rel.* Oklahoma State Board of Medical Licensure and Supervision (“Board”), charging you with violations of the Medical Practice Act at 59 O.S. §§ 509(5), (8), (13); Okla. Admin. Code §§ 435:10-7-4(10), (11).

On **May 16, 2024**, the Board will be in regular session at **9:00 o’clock a.m.**, at its offices located at **101 N.E. 51st Street, Oklahoma City, Oklahoma 73105**, at which time your Complaint will be considered by the Board, and a hearing will be held pursuant to the Oklahoma Administrative Procedures Act, 75 O.S. § 250, *et seq.*

If the Board decides, after considering all the testimony and evidence, that you are guilty as charged, your license to practice within the State of Oklahoma may be suspended or revoked or other disciplinary action may be taken by the Board as authorized by law, including the assessment of costs and attorney’s fees for this action as provided by law.

Under the laws of the State of Oklahoma, you are required to file your written Answer under oath with the Secretary of the Board within twenty (20) days after the Citation is served upon you. Unless your Answer is so filed, you will be considered in default, and the Board may accept the allegations set forth in the Complaint as true at the hearing of the Complaint. If the charges are deemed sufficient by the Board, your license to practice in the State of Oklahoma may be suspended or revoked.

YOUR HONOR, HEREBY NOTICED that on the 14th day of March 2024, the Oklahoma State Board of Medical Licensure and Supervision (the Board) has received a complaint from the Oklahoma State Board of Medical Licensure and Supervision (the Board) charging that you, as a member of the Medical Practice Act in 20 O.S. § 2001 (2023), (82-11-1) (aka, "Whole Code"), have violated the provisions of the Medical Practice Act in 20 O.S. § 2001 (2023), (82-11-1) (aka, "Whole Code").

On May 16, 2024, the Board will be holding a hearing session at 9:00 a.m. at its office located at 601 N.E. 5th Street, Oklahoma City, Oklahoma 73102, at which time your complaint will be considered by the Board and a hearing will be held pursuant to the Oklahoma Administrative Procedures Act 77 O.S. § 120 et seq.

If the Board decides after reviewing all the testimony and evidence that you are not a fit to practice medicine in the State of Oklahoma and be suspended or restricted from practicing medicine in the State of Oklahoma, the Board may suspend or restrict your license to practice medicine in the State of Oklahoma. The Board may also take any other action that it deems appropriate and necessary for the protection of the public.

Under the laws of the State of Oklahoma, you are required to file your written answer to this citation with the Secretary of the Board within twenty (20) days after the citation is served upon you. If your answer is not filed, you will be considered to have admitted the Board's charges and the Board may suspend or restrict your license to practice in the State of Oklahoma. If the Board finds that you are not a fit to practice in the State of Oklahoma, you may be suspended or restricted from practicing medicine in the State of Oklahoma.

THEREFORE, you are cited to appear at the hearing set forth above. If you are not present in person, you may be present through your attorney.
