**ORDER DENYING REQUEST FOR
RESTRICTIONS TO BE REMOVED**

This cause came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision (the "Board") on January 8, 2013, at the office of the Board, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

E. Marissa Lane, Assistant Attorney General, appeared for the plaintiff and Defendant appeared in person and with Counsel, Robert L. Swartz.

The Board *en banc*, being fully advised in the premises and hearing sworn testimony from the Defendant, found that there is clear and convincing evidence to support the following Findings of Fact, Conclusions of Law and Orders:

Findings of Fact

1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §480 *et seq.* The Board has jurisdiction over this matter, and notice has been given in all respects in accordance with law and the rules of the Board.

2. Defendant, Suzzie Waldenville, PA, holds Physician Assistant license no. PA627.

Conclusions of Law

1. The Board has jurisdiction and authority over the Defendant and subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act (the "Act") and its applicable regulations. The Board is authorized to enforce the Act as necessary to protect the public health, safety and welfare.

2. Defendant failed to provide clear and convincing evidence to the Board in support of removing her restrictions which were placed in the Final Order of Reprimand filed herein on May 25, 2012.

3. The Board further found that the license of Suzzie Waldenville, No. PA672, should remain under the same restrictions as set forth in the Final Order of Reprimand filed herein on May 25, 2012.


Order

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:

1. The license of Suzzie Waldenville, No. PA672, is to remain under the same restrictions as set forth in the Final Order of Reprimand filed herein on May 25, 2012.

2. Promptly upon receipt of an invoice, Defendant shall pay all costs of this action authorized by law, including without limitation, legal fees and costs, investigation costs, staff time, salary and travel expenses, witness fees and attorney's fees.
