ORDER TERMINATING PROBATION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on March 16, 1991, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Winfred L. Medcalf, M.D., Defendant, and Attorney, Mona S. Lambird, of Andrews, Davis, Legg, Bixler, Milsten & Price, 500 West Main, Oklahoma City, Oklahoma, appeared by announcement.

The Board of Medical Licensure and Supervision en banc heard oral argument, reviewed exhibits, and being fully advised in the premises, the Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Defendant, Winfred L. Medcalf, M.D., holds Oklahoma Medical License No. 7115.

2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That following notice and hearing on or around October 27, 1990, Defendant's medical license was placed on probation to the Oklahoma State Board of Medical Licensure and Supervision for a period of three (3) years beginning on October 27, 1990, under certain enumerated terms and conditions.

4. That subsequent to the entry of the above Order, the Defendant has requested fully retired status from the Oklahoma Board of Medical Licensure and Supervision, and did on March 7, 1991, forward his \$50.00 processing fee.

5. That in view of evidence presented, the Defendant's probation to the Oklahoma State Board of Medical Licensure and Supervision should be terminated, set aside and held for naught.

CONCLUSIONS OF LAW


1. That the Defendant remains under the jurisdiction of the Oklahoma Board of Medical Licensure and Supervision and it is within the judgment and discretion of the Board to modify terms and conditions as reflected by evidence received in the record.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:


1. That the probation previously imposed on Defendant, Winfred L. Medcalf, M.D., holding Oklahoma Medical License No. 7115, should be terminated, set aside and held for naught.
2. That the Board should accept Defendant's application for fully retired status.
3. In the event Defendant again applies for active status of his Oklahoma license as a physician and surgeon, then he must personally appear before the Board and provide evidence as to continued clinical competency therefor.
4. That Defendant, by and through his counsel, should receive a copy of this Order as soon as possible.


