ORDER TERMINATING PROBATION

Defendant's Second Amended Motion came on for hearing before the Oklahoma Board of Medical Examiners en banc on January 15, 1987, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff, and Dale Jarvis, Attorney, appeared on behalf of the Defendant, and Defendant Douglas Doyn Leatherman appeared in person.

The Board of Medical Examiners en banc heard the testimony and reviewed exhibits, and being fully advised in the premises the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That Douglas Doyn Leatherman, M.D., holds Oklahoma Medical License No. 7303, which is different from the number we have had previously in the caption.

2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That since September 21, 1984, the Defendant has been under terms and conditions of probation as set forth in that Order and since that time the Defendant has cooperated with the Board in all respects concerning his physical and mental state and any treatment pertaining thereto.

4. That the Defendant is in the process of selling his home in Weatherford, Oklahoma, and desires to consult at Bass Hospital, Enid, Oklahoma, or to teach in the family practice residency in Enid and to not be in private practice.

5. That terminating the Defendant's probation would benefit the Defendant in his physical and mental health and would be consistent with the Defendant's prior conduct.

CONCLUSIONS OF LAW

1. That the Board has continuing jurisdiction over the Defendant pursuant to 59 O.S. 1981, Section 506, and the Board may in its discretion remove or terminate probation that it previously imposed.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:

1. That the Defendant, Douglas Doyn Leatherman, M.D., holding Oklahoma Medical License No. 7303, be and is hereby released from the terms and conditions of probation as originally set out by the Board in the Final Order of September 21, 1984, and said probation is terminated and of no further force and effect.


2. That a copy of this Order should be placed in the Defendant's file and a copy should also be forwarded to the Defendant for his records.
