ORDER REINSTATING MEDICAL LICENSE

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on May 19, 1990, at the office of the Oklahoma Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and John Thomas Forsythe, M.D., Defendant, appeared, pro se, without counsel and announced he was ready to proceed without assistance of counsel.

The Board of Medical Licensure and Supervision en banc reviewed the Application and all attached exhibits, heard testimony, and being fully advised in the premises, the Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That the Applicant is applying for reinstatement of licensure in Oklahoma as a physician and surgeon.

2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That following notice and hearing on May 1, 1988, Defendant's license was placed on probation to the Oklahoma State Board of Medical Licensure and Supervision for a period of five years, beginning on May 1, 1988, under certain enumerated terms and conditions.

4. That following notice and hearing on February 2, 1990, the Board ordered Defendant to continue under the five year probation effective May 1, 1988, under the same terms and conditions, and that within 30 days he should bring current his arrearage of unpaid investigation, prosecution and probation costs, or personally meet with the Board Secretary and produce financial statements and tax documents concerning his financial circumstances and work out a repayment plan acceptable to the Secretary.

5. That the Defendant has been in compliance with the terms and conditions of probation, except that he has not repaid the investigation, prosecution and probation costs to the Board in the present approximate amount of \$2,077.00.

6. That the Defendant has offered to voluntarily surrender his Oklahoma license with the Bureau of Narcotics and Dangerous Drugs and with the United States DEA on writing controlled dangerous substances.

CONCLUSIONS OF LAW

1. That the Defendant remains under the jurisdiction of the Oklahoma Board of Medical Licensure and Supervision and any modification or termination of probation is within the Board's discretion and judgment.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the Defendant's application for restoration of an unmodified Oklahoma medical license should be and the same is hereby GRANTED.

2. That the five year probation effective May 1, 1988, imposed by the Oklahoma Board of Medical Licensure and Supervision is specifically set aside and held for naught.

3. That the Defendant shall voluntarily surrender his State and Federal licenses to prescribe, administer or dispense controlled dangerous substances to the Oklahoma Bureau of Narcotics and Dangerous Drugs and the United States Drug Enforcement Authority, respectively.

4. That beginning on September 1, 1990, Defendant will begin repayments of arrearage on unpaid investigation, prosecution and probation costs to the Oklahoma Board in the amount of at least \$100.00 per month and shall have all arrearage paid off by December 31, 1990.
