
ORDER OF EMERGENCY SUSPENSION


On this 31st day of August, 1998, the Plaintiff's application for emergency suspension of Defendant, John T. Forsythe, M.D., Oklahoma Medical License No. 7562, comes on for hearing before the Secretary of the Oklahoma State Board of Medical Licensure and Supervision (the "Board"). Susan Moebius Henderson, Assistant Attorney General, appears on behalf of the Plaintiff, the State of Oklahoma ex rel. the Oklahoma State Board of Medical Licensure and Supervision. Defendant appears in person and with his attorney, Curtis A. Parks.

The Secretary makes the following findings of fact and conclusions of law:


1. Defendant, John T. Forsythe is licensed as a physician and surgeon in the State of Oklahoma and holds Oklahoma Medical License No. 7562.
2. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §480 *et seq.* The Board has jurisdiction over these proceedings, and notice has been given in accordance with law.
3. The parties have agreed that Defendant's medical license should be suspended in lieu of proceeding with the emergency hearing scheduled this day.
4. All of the charges in the First Amended Complaint and Citation will be heard before the Board *en banc* at its regularly scheduled meeting on September 24-25, 1998 (and continuing to Saturday, September 26, as necessary). Defendant will not seek a continuance beyond the September hearing date.
5. The emergency suspension shall be reported to the National Practitioner Data Bank and all other appropriate groups.

6. Defendant will surrender his Oklahoma wallet card and certificate of medical license to the Board on or before 4:30 p.m., August 31, 1998.


