THE STATE OF OKLAHOMA TO DOCTOR GEORGE CONRAD MARKERT, STROUD, OKLAHOMA:

You are hereby notified that on the 11th day of February, 1976, a sworn complaint was filed with the undersigned Secretary of the State Board of Medical Examiners of Oklahoma, charging you with being guilty of unprofessional conduct within the meaning of Subsections 6 and 8, Section 509, Title 59, Oklahoma Statutes 1971, as amended, a copy of said complaint being attached hereto for your information; that on the 13th day of March, 1976, said Board will be in regular session at 9:30 o'clock a.m., at 3013 N. W. 59th, Oklahoma City, Oklahoma, at which time said complaint will be considered by the Board; that if it be the decision of the Board after considering all of the testimony presented, that you are guilty as charged, your license to practice medicine and surgery within the State of Oklahoma will be suspended or revoked or such other disciplinary action taken by the Board as may be authorized by law; that under the laws of Oklahoma you are required to file your written answer under oath with the Secretary of said Board, to-wit: E. W. Young, Jr., M.D., Oklahoma City, Oklahoma, within twenty days after this citation is served upon you and to therewith deposit with said Secretary your license or certificate authorizing you to practice medicine and surgery within the State of Oklahoma; that unless said answer and said license or certificate be so filed you will be considered in default and, if the charges be deemed sufficient by the Board, your said license or certificate will be suspended



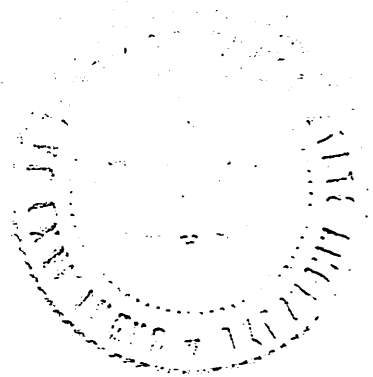
