STIPULATION AND AGREEMENT
OF WALTER L. BOWLAN, M.D.

COMES NOW the Defendant, Walter L. Bowlan, M.D., the undersigned, and states that on this day of June, 1992, he is of sound mind and not under the influence of any medication or drug or impaired therefrom; that said Defendant does fully recognize his right to legal counsel, and has reviewed this document with Stephen R. Stephens, Fellers, Snider, Blankenship, Bailey & Tippens, 2400 First National Center, 120 N. Robinson, Oklahoma City, OK 73102-7875; and does hereby voluntarily and of his own volition agree to the following stipulations, to-wit:


1. That until final disposition of this case by the Board, the Defendant will not allow his son, Mark Bowlan, or any other unlicensed person, to practice medicine and surgery in the Defendant's office suite at Mercy Health Center or at any other location under the dominion and control of the Defendant.

That until final disposition of this case by the Board, the Defendant will not directly or indirectly employ his son, Mark Bowlan, or allow Mark Bowlan to work paid or unpaid in the Defendant's office or any other location under the dominion and control of the Defendant, in any medical capacity, to include but not limited to, as a physician, physician's assistant, nurse, clerk, technician, receptionist, office manager, business manager, or record clerk.


3. That the Defendant specifically understands that until final disposition of this case by the Board, investigators of the Board will randomly visit Defendant's office or any other location under the dominion and control of the Defendant, and any violation of the terms and conditions herein shall be reported to the Board at the time of the hearing on the merits.

4. It is specifically noted that the Defendant retains all factual and affirmative defenses and preserves any additional defenses or motions hereinafter pled.


