ORDER AMENDING TERMS OF PROBATION

The Defendant appeared before the Oklahoma Board of Medical Examiners en banc on September 27, 1985, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

The Board of Medical Examiners en banc reviewed the exhibits and being fully advised in the premises the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

- 1. That on or around September 17, 1982, following notice and hearing, the Oklahoma Board of Medical Examiners ordered that Defendant be placed on five years probation under certain terms and conditions.
- 2. That during the term of his probation to date, the Board has no evidence of any violation of any terms and conditions of probation.
- 3. That the Defendant requested permission to administer, prescribe and dispense Schedule III drugs and for permission to apply to the Drug Enforcement Authority and the Bureau of Narcotics and Dangerous Drugs for such authority.

CONCLUSIONS OF LAW

1. That the Defendant is still under the continuing jurisdiction of the Oklahoma Board of Medical Examiners pursuant to its statutory authority, 59 O.S. 1981, §481, et seq.

ORDER

- IT IS THEREFORE ORDERED by the Board of Medical Examiners of the State of Oklahoma as follows:
- 1. That the terms of probation originally imposed on the Defendant by Order of September 17, 1982, remain in full force and effect except that Defendant may administer, prescribe or dispense Schedule III drugs and may be permitted to re-apply upon his own initiative to the Drug Enforcement Authority and the Bureau of Narcotics and Dangerous Drugs.

2. That all other terms and conditions of probation imposed on the Defendant by Order of September 17, 1982, remain in full force and effect.
