ORDER OF CONTINUANCE
AND SUSPENSION OF LICENSE

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on June 8, 1990, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Lanny G. Anderson, M.D., Defendant, appeared by and through counsel, William Jack, by announcement.

The Board of Medical Licensure and Supervision en banc reviewed exhibits, and being fully advised in the premises, the Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Defendant, Lanny G. Anderson, M.D., holds Oklahoma Medical License No. 7810.

2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That on or around April 12, 1990, Complaint and Citation were issued against the Defendant. Said pleadings were served on the Defendant's counsel, William Jack, on May 2, 1990, at his office address of 525 Central Park, Suite 107, Oklahoma City, Oklahoma.

4. That Defendant is now reported to be participating as an in-patient at Talbott Center, Georgia.

5. Suspension of license until further order will ensure that Defendant shall not practice without submitting evidence of successful completion of in-patient rehabilitation to the Board.

CONCLUSIONS OF LAW

1. That a continuance of the case is within the judgment and discretion of the Board in the handling of its docket under the Oklahoma Medical Practice Act, 59 O.S. Supp. 1989, Sec. 481 et seq.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That hearing on the Complaint and Citation involving Defendant, Lanny G. Anderson, M.D., holding Oklahoma Medical License No. 7810, should be and the same is hereby CONTINUED and postponed from June 8, 1990, to whenever Defendant completes in-patient treatment and makes application or motion with the Board to reset the aforesaid hearing.

2. It is further ordered that Defendant's Oklahoma Medical License No. 7810 should be and is hereby SUSPENDED until successful completion of in-patient treatment at Talbott Center, Georgia.


3. That the Board specifically makes no final findings or determinations on any of the allegations of the Complaint and reserves judgment thereon.
