**ORDER TABLING APPLICATION**

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on January 10, 2013 at the office of the Board, 101 N.E. 51<sup>st</sup> Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Applicant did not appear.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact:

**FINDINGS OF FACT**

1. Applicant applied for reinstatement of his Occupational Therapy Assistant license.
2. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.
3. Applicant received notice via U.S. Certified Mail. Applicant contacted the Executive Director to verify receipt of service and to advise Executive Director he would not be attending the Board Meeting scheduled for January 10, 2013.

## CONCLUSIONS OF LAW



The Board has legal authority to table an application when evidence on ~~the application is insufficient to allow evaluation by the board to make a~~ final judgment as to whether the Applicant fulfills the requirements of 59 Okla. Stat. §888.1 *et seq.*, and the applicable rules of the Board to qualify for reinstatement of the Occupational Therapy Assistant license.

## ORDER

It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. The Application of **JOSEPH JOHN BAKER** for the reinstatement of his Occupational Therapy Assistant license in Oklahoma should be **TABLED**.
