**VOLUNTARY SURRENDER OF LICENSE IN LIEU OF PROSECUTION**

I, Jana Kaye Haynes, Licensed Dietician ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:

1. I hereby voluntarily surrender my Licensed Dietitian License No. LD 826, effective September 19, 2024. 59 O.S. 509.1(E), *et seq.*
2. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
3. I admit that I am the subject of a proceeding by the Oklahoma State Board of Medical Licensure and Supervision ("Board") involving allegations which, if proven, would constitute grounds for disciplinary action by the Board.
4. My Licensed Dietitian License expired on October 31, 2018. I didn't apply for renewal until 2024. During that time, I practiced as a dietitian for Spanish Cove since 2000.
5. I am guilty of violating the following rules of professional conduct:
  - A. Any violation of the provisions of the Licensed Dietitian Act in violation of 59 Okla. Stat. § 1738(A)(1);
    - i. A person may not use the title or represent or imply that he or she

has the title of licensed dietitian or provisional licensed dietitian or use the letters LD or PLD and may not use any facsimile of those titles in any manner to indicate or imply that the person is a licensed dietitian or provisional licensed dietitian, unless that person holds an appropriate license. 59 O.S. § 1736(A)


- B. Any violation of a rule adopted by the Advisory Committee on Dietetic Registration of the State Board of Medical Examiners in violation of 59 Okla. Stat. § 1738(A)(2);
- i. OAC 435:35-1-4(c)(1)(A) A licensee shall not misrepresent any professional qualifications or credentials
  - ii. OAC 435:35-1-4(c)(3)(B) Integrity in personal and organizational behaviors and practices (Autonomy) Nutrition and dietetics practitioners shall:
    - (ii) Comply with all applicable laws and regulations, including obtaining/maintaining a state license or certification if engaged in practice governed by nutrition and dietetics statutes.

6. I will submit my wallet card and wall certificate as evidence of my intent to surrender my license. 59 O.S. § 509.1(E)(2).
7. I hereby agree that I will not reapply for reinstatement of my Oklahoma Licensed Dietician license for a minimum of one (1) year from the date this Voluntary Surrender in Lieu of Prosecution ("SILOP") is accepted by the Board. If I am reinstated, I agree it will be under probation with terms and conditions to be determined by the Board at the time of reinstatement.
8. If the Board does not accept this Voluntary Surrender In Lieu of Prosecution the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against Defendant in a subsequent disciplinary hearing. Defendant will be free to defend herself, and no inferences will be made from her willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
9. As a condition to accepting my voluntary surrender of license in lieu of prosecution, I acknowledge that the Board shall require me to pay all costs expended by the Board for any legal fees and cost, any investigation, probation and monitoring fees, including but not

limited to staff time, salary and travel expense, witness fees and attorney fees. I understand that the Board will provide an itemized statement of fees.
