COMPLAINT

COMES NOW D.C. Mosshart, Inspector for the Oklahoma Board of Medical Examiners, being first duly sworn upon oath and states:

- 1. That Larry Wayne Cartmell, M.D., holding Oklahoma Medical License No. 8286, is in violation of the Oklahoma Medical Practice Act, 59 O.S. 1981, \$509, Paragraphs 13 and 17, to-wit:
 - "13. Prescribe or administer a drug or treatment without sufficient examination and the establishment of a valid physician-patient relationship."
 - "17. Prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, or prescribing, dispensing, or administering controlled substances or narcotic drugs without medical need in accordance with published standards."
- 2. That Larry Wayne Cartmell, M.D., is in violation of the Rules and Regulations promulgated by this Board, specifically Section IX, Rules 1, 2 and 6, to-wit:
 - "Rule 1: Indiscriminate or excessive prescribing, dispensing or administering of controlled or narcotic drugs."
 - "Rule 2: Prescribing, dispensing or administering of controlled or narcotic drugs in excess of the amount considered good medical practice."
 - "Rule 6: Dispensing, prescribing or administering a controlled substance or narcotic drug without medical need."
- 3. That from December 22, 1982, through June 20, 1984, Dr Cartmell wrote approximately 78 prescriptions for Schedule II drugs (Percodan) for a person, G.S., for a total number of 2,340 dosage units and an average of 4.28 dosage units per day. That during the same period the Defendant wrote approximately eight

prescriptions for Schedule III drug Didrex for the same person, G.S., for a total number of 310 dosage units

- 4. That Defendant Larry Wayne Cartmell, M.D., did prescribe and administer or dispense the Schedule II drug Percodan and the Schedule III drug Didrex to a person, G.S., without sufficient or complete physical examination and without the establishment of a valid physician-patient relationship.
- 5. That a prescription survey conducted in reference to certain scheduled drugs reveals that the Schedule III drug Percodan and the Schedule III drug Didrex were prescribed by Larry W. Cartmell, M.D. for person G.S. in generally increasing amounts per month and in excess of the amount considered for the medical need presented.

WHEREFORE, Complainant prays this Board to conduct a hearing and upon proof of the allegations contained herein that such disciplinary action be taken by the Board as in authorized by law.
