VOLUNTARY SURRENDER OF LICENSE IN LIEU OF PROSECUTION



I, Hannah Leah Monroe, OA ("Defendant"), being of lawful age and after first being duly sworn, depose and state as follows:

1. I desire and hereby do voluntarily surrender my Oklahoma occupational therapy assistant license no. 831. 59 O.S. 509.1(E), *et seq.*
2. The surrender of my license is freely and voluntarily made. I have not been subject to any coercion or duress, and I am fully aware of the consequences of the surrender of my license.
3. I am the subject of an investigation and proceeding by the Oklahoma State Board of Medical Licensure and Supervision ("Board") involving allegations which, if proven in a hearing on the matter, would constitute grounds for disciplinary action by the Board.
4. On April 9, 2019 I was charged with violation of 21 O.S. § 645, Assault with a Dangerous Weapon, a felony, in the District Court of Cleveland County, State of Oklahoma.
5. On October 22, 2019 I submitted my Application for Renewal of Oklahoma License to the Board requesting renewal of my occupational therapist assistant license for calendar year 2020, in which I indicated that I had not been arrested, charged or convicted of a felony.

6. On October 30, 2020 I submitted my Application for Renewal of Oklahoma License to the Board requesting renewal of my occupational therapist assistant license for calendar year 2021, in which I indicated that I had not been arrested, charged or convicted of a felony.
7. On October 27, 2021 I submitted my Application for Renewal of Oklahoma License to the Board requesting renewal of my occupational therapist assistant license for calendar year 2022, in which I indicated that I had not been arrested, charged or convicted of a felony.
8. I am guilty of unprofessional conduct by violating the following rules of professional conduct:
  - a. Participation in fraud, abuse and/or violation of state laws, in violation of Okla. Admin. Code § 435:30-1-10(5).
  - b. Obtaining or attempting to obtain a license, certificate or documents of any form as an occupational therapist or occupational therapy assistant by fraud or deception, in violation of Okla. Admin. Code § 435:30-1-10(23).
  - c. Failure to report to the Board any adverse action taken against him or her by another licensing jurisdiction (United States or foreign), by any governmental agency, by any law enforcement agency, or by a court for acts or conduct similar to acts or conduct that would constitute grounds for action as defined in this section, in violation of Okla. Admin. Code § 435:30-1-10(29).
9. I hereby submit my wallet card and wall certificate as evidence of my intent to surrender my license. 59 O.S. § 509(E)(2).
10. I understand that I am ineligible to apply for reinstatement of my Oklahoma medical occupational therapist license for a minimum of one (1) year from the date this surrender is accepted by the Board.
11. If the Board does not accept this Voluntary Surrender of License in Lieu of Prosecution, the Plaintiff and Defendant (collectively, the "Parties") stipulate that it shall be regarded as null and void. Admissions by Defendant herein, if any, shall not be regarded as evidence against him in a subsequent disciplinary hearing. Defendant will be free to defend himself, and no inferences will be made from his willingness to have this Order accepted by the Board. The Parties stipulate that neither the presentation of the Order nor the Board's consideration of this Order shall be deemed to have unfairly or illegally prejudiced the Board or its individual members and, therefore, shall not be grounds for precluding the Board nor any individual Board member from further participation in proceedings related to the matters set forth herein.
