ORDER TO COMPLETE EVALUATION ON BOUNDARIES ISSUES

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on March 10, 2011, at the office of the Board, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Defendant appeared in person and pro se.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact:

FINDINGS OF FACT.

- 1. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.
- 2. On or about November 4, 2010, after full hearing before the Board en banc, the Board entered a Final Order of Administrative Fine and Order for Boundaries Evaluation wherein Defendant was ordered to pay \$5,000.00, complete a Boundaries Course, and submit to an Evaluation on Boundaries Issues, all within three (3) months of the date of the Order. After that time, Defendant was ordered to appear before the Board to report on the evaluation.
- 3. The evidence reflects that on or about March 10, 2011, Defendant appeared before the Board. At that time, he reported that he had paid the fine and had completed the Boundaries Course. However, he had not submitted to the Evaluation on Boundaries Issues.

4. Defendant shall immediately complete the Evaluation on Boundaries Issues as set forth in the November 4, 2010 Order and shall return to the Board at the May 19, 2011 Board meeting to report on the evaluation.

ORDER

It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows:

- 1. SCOTT GREGORY BEARDEN shall immediately comply with the November 4, 2010 Order by completing the Evaluation on Boundaries Issues and appearing before the Board at its May 19, 2011 meeting to report on his evaluation. Failure to complete the evaluation as ordered in the November 4, 2010 Order prior to the May 19, 2011 Board meeting may result in further disciplinary action on Defendant's license to practice as a physician assistant.
- 2. A copy of this written order should be sent to the Defendant as soon as it is processed.
