FINAL ORDER OF SUSPENSION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on May 19, 2011, at the office of the Board, 101 N.E. 51st Street, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Defendant appeared in person and pro se.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact:

FINDINGS OF FACT.

1. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.

2. On or about November 4, 2010, after full hearing before the Board *en banc*, the Board entered a Final Order of Administrative Fine and Order for Boundaries Evaluation wherein Defendant was ordered to pay \$5,000.00, complete a Boundaries Course, and submit to an Evaluation on Boundaries Issues, all within three (3) months of the date of the Order. After that time, Defendant was ordered to appear before the Board to report on the evaluation.

3. The evidence reflects that on or about March 10, 2011, Defendant appeared before the Board. At that time, he reported that he had paid the fine and had completed the Boundaries Course. However, he had not submitted to the Evaluation on Boundaries Issues.

4. After full hearing by the Board *en banc*, the Board entered an Order to Complete Evaluation on Boundaries Issues, wherein Defendant was ordered to complete the Evaluation on

Boundaries Issues and to appear before the Board at its May 19, 2011 meeting to report on the evaluation. The Board further ordered that failure to complete the evaluation as ordered in the November 4, 2010 Order prior to the May 19, 2011 Board meeting could result in further disciplinary action on Defendant's license to practice as a physician assistant.

4. On May 19, 2011, Defendant appeared before the Board. At that time, he reported that he had not completed the Evaluation on Boundaries Issues as previously ordered. The evidence reflected that Defendant had scheduled an appointment at Sante Center for Healing, but had cancelled it after he was asked to sign a consent for Sante to obtain certain collateral information and to consent to a polygraph examination, both of which he refused to do.


ORDER

It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. **SCOTT GREGORY BEARDEN** is immediately **SUSPENDED** until he completes the Evaluation on Boundaries Issues and appears before the Board to report on his evaluation, at which time he may request reinstatement of his license. Defendant is additionally ordered to comply fully with all requests of the assessment facility.


2. A copy of this written order should be sent to the Defendant as soon as it is processed.
