ORDER DENYING APPLICANT'S REQUEST FOR MODIFICATION OF PROBATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on July 14, 2011, at the Board's office, 101 N.E. 51st Street, Oklahoma City, Oklahoma 73105, pursuant to notice given as required by law and rules of the Board.

Jaemie Ann Waters, P.A., appeared in person, pro se, thereby waiving her right to legal counsel at the hearing.

The Board *en banc* heard testimony, reviewed the exhibits presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

Findings of Fact

- 1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
- 2. Ms. Waters currently holds Oklahoma physician assistant license no. PA842 under an indefinite term of probation that commenced on July 19, 2007.
- 3. On July 14, 2011, Ms. Waters requested that the terms of her probation be modified to allow her to redact the Findings of Fact from her Revised Final Order of Probation when giving a copy of the Order to potential employers as required by paragraph 1(C).

4. Ms. Waters failed to present sufficient evidence to support the requested modification.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to hear requests for modification of licenses under 59 Okla. Stat. §480 *et seq*.
- 2. The Board may impose practice parameters and other restrictions as necessary to protect the health, safety and welfare of the public under 59 Okla. Stat. §480 *et seq.*

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

- 1. Ms. Waters' request for modification to her terms of probation to allow her to redact the Findings of Fact from her Revised Final Order of Probation when giving a copy of the Order to potential employers as required by paragraph 1(C) is **DENIED**.
 - 2. A copy of this written order shall be sent to Ms. Waters as soon as it is processed.
