ORDER TABLING LICENSURE APPLICATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on May 17, 2007, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board. Applicant appeared in person.

The Board *en banc* heard testimony, reviewed the application and all attached exhibits, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. Applicant applied for reinstatement of his license in Oklahoma as a physician and surgeon.

2. The Board *en banc* has jurisdiction over the subject matter herein and notice has been given in all respects as required by law and the rules of the Board.

3. The evidence reflects that the reinstatement application of JIMMIE LEE REED was initially heard on June 24, 2005 before the Board *en banc*. Questions were raised regarding his past substance abuse, his Agreed Order with the Texas State Board of Medical Examiners, his past treatment and recovery status. The Board requested that the application be tabled until the Applicant (a) establishes a relationship with the Oklahoma Health Professionals Recovery Program and submits a report from the OHPRP; (b) obtains a neuropsychological evaluation, with the Menninger's report being made available to the person conducting the evaluation; and (c) takes the SPEX examination.

4. Applicant's request for reinstatement was tabled at that time without further consideration so as to allow the Applicant to submit the information requested by the Board.

5. The reinstatement application of JIMMIE LEE REED was heard again on May 17, 2007 before the Board *en banc*. Questions were raised regarding the Applicant's competence to practice radiology, his practice since 1993 and his current psychiatric state. The Board requested that the application be tabled until the Applicant (a) submits a current assessment or review by a neurologist; (b) submits a current assessment or review by a neuro-ophthalmologist; (c) submits a current assessment or report from a radiologist or radiology group as to Applicant's current competence to practice radiology; (d) submits an assessment or report from an M.D. or D.O. psychiatrist regarding his current psychiatric state; and (e) submits documentation of his radiology practice from 1993 until the present time.

6. Applicant's request for reinstatement should be tabled at this time without further consideration so as to allow the Applicant to submit the information requested by the Board.

CONCLUSIONS OF LAW

1. The Board has legal authority to table an application when evidence on the application is insufficient to allow evaluation by the Board to make a final judgment as to whether the Applicant fulfills the requirements of 59 Okla. Stat. §481 *et seq.*, and the applicable rules of the Board to qualify for licensure in Oklahoma as a physician and surgeon.

ORDER


It is therefore **ORDERED** by the Board of Medical Licensure and Supervision as follows:

1. The reinstatement application of JIMMIE LEE REED for licensure in Oklahoma as a physician and surgeon should be **TABLED**.

2. The Board will make no further consideration on this application until Applicant (a) submits a current assessment or review by a neurologist; (b) submits a current assessment or review by a neuro-ophthalmologist; (c) submits a current assessment or report from a radiologist or radiology group as to Applicant's current competence to practice radiology; (d) submits an assessment or report from an M.D. or D.O. psychiatrist regarding his current psychiatric state; and (e) submits documentation of his radiology practice from 1993 until the present time.

3. A copy of this written order should be sent to the Applicant as soon as it is processed.
