COMPLAINT

Comes now Michael Hoover, Inspector for the State Board of Medical Examiners, Oklahoma City, Oklahoma, being first duly sworn upon oath, states:

- 1. That Joe Dan Metcalf, M.D., holding Oklahoma

 Medical License No. 8629, is charged with unprofessional conduct,
 to wit: Violating the Oklahoma Medical Practice Act, 59 O.S.

 Supplement 1976, \$509, more specifically subsections 9 and 13
 and Rule 29 of the State Board of Medical Examiners Rules and

 Regulations, subsections (a) and (b):
 - "(9) Dishonorable or immoral conduct which is likely to deceive or defraud the public.
 - (a) Indiscriminate or excessive prescribing of controlled or narcotic drugs;
- 2. That Joe Dan Metcalf, M.D., is deceiving the public by writing prescriptions for controlled substances which have antagonistic effects that do not promote either cure or palliation; specifically the prescribing of amphetamine containing compounds at the same time as prescribing depressant compounds (i.e. Dexedrine and Percodan) to the same patient, to wit:
