ORDER TO CONTINUE HEARING

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on September 26, 1996, at the offices of the Board, 5104 North Francis, Suite C, Oklahoma City, Oklahoma.

Merle Gile, Attorney, appeared for the Plaintiff.

The Oklahoma Board of Medical Licensure and Supervision heard a motion to continue this hearing until November 14, 15, 16, 1996 as presented by Mr. Gile. Gary Richardson, Attorney for the Defendant, has agreed that Defendant, Joe Dan Metcalf, will not practice medicine and surgery until he is able to appear before the Board. Being fully advised in the premises, the Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

1. That Defendant, Joe Dan Metcalf holds Oklahoma Medical License Number 8629.
2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That the Motion for Continuance did contain grounds to support continuance of evidentiary hearing and said motion may be granted without danger to public health, safety and welfare.

CONCLUSIONS OF LAW

1. That the grounds for the continuance were sufficient to

obtain continuance of the evidentiary hearing herein.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:

1. That hearing on the matter before the Board in this instance should and is hereby continued to the November 14, 15, 16, 1996 meeting of the Board with the agreement that Defendant, Joe Dan Metcalf, will not practice medicine and surgery until he appears before the Board.
