ORDER

This matter comes before the Oklahoma State Board of Medical Licensure and Supervision on this 26th day of September, 1996, upon the Staff Application for Declaratory Judgment and/or to Settle Terms of Final Order, the defendant's Request for Reconsideration or Clarification and the defendant's Application for Stay.

The Board, finds that the Staff's Application to Settle Terms of Final Order should be granted and that the suspension of the defendant, Malcolm G. Robinson, M.D., should continue in effect until an evaluation, and treatment if necessary, as set forth in this Board's Order of August 23, 1996, be conducted. The Board further finds that the Order of August 23, 1996, should be modified in part such that the evaluation and treatment referenced therein not be conducted by Dr. Richard Irons and that the defendant be allowed to choose as an evaluating person any one of the following: Dr. Patrick Karnes, Dr. Daniel Hardy or a third person as may be recommended to the Staff by the American Board of

Addictionology. The Board further finds that the defendant's Application for Stay should be denied.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Staff Application to Settle Terms of Final Order be and is hereby sustained.


IT IS FURTHER ORDERED ADJUDGED AND DECREED that the defendant's Application to stay be and is hereby denied.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Board's Order of August 23, 1996, be modified such that the term of suspension imposed upon the defendant remain in full force and effect until such time as the defendant submits himself to evaluation and treatment, if necessary, from any one of the below-referenced persons.


