ORDER

This cause came on for hearing before the Oklahoma Board of Medical Examiners en banc on April 25, 1986, at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff and the Defendant appeared in person without counsel.

The Board of Medical Examiners en banc heard the testimony, reviewed exhibits and being fully advised in the premises, the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That F. Rollin Bland, M.D., holds Oklahoma Medical License No. 9084.

2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.

3. That the Defendant requested termination of probation which was imposed by the Board following its meeting on September 27, 1985, and set forth in the Final Order received by the State Board of Medical Examiners on October 21, 1985.

4. That evidence indicated that the Defendant was in compliance with the terms of his probation, including specifically that he kept duplicate, serially-numbered prescriptions for all controlled dangerous substances prescribed and the Defendant presented those records for inspection to the members of the Oklahoma State Board of Medical Examiners en banc.

5. That a review of those prescriptions indicated that the Defendant had not materially or substantially changed his prescribing habits and that said duplicate prescriptions did not form a basis on which the Board could comply with his request for a termination of probation.

CONCLUSIONS OF LAW

1. That the Board retains continuing jurisdiction over Defendant, F. Rollin Bland, M.D., Medical License No. 9084, based on its Final Order issued following hearing on September 27, 1985, and based on 59 O.S. 1981, §481, et seq.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:


1. That the Defendant's request for termination of probation should be and the same is hereby denied and the Defendant is hereby ordered to remain under the terms of probation as previously set forth in the Order that issued following hearing on September 27, 1985.

2. IT IS FURTHER ORDERED that agents of the Oklahoma Board of Medical Examiners conduct another prescription survey concerning Dr. Bland before the time of the next Board meeting and also counsel in depth with Dr. Bland concerning his prescription-writing habits and compliance with the previous Orders of this Board.
