Daniel J. Gamino, Attorney, appeared for the Plaintiff and Bill E. D. Williams, Attorney, appeared for the Defendant.

The Board of Medical Examiners en banc heard the testimony and reviewed exhibits and being fully advised in the premises the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That Mary Ann Gilliam, M.D., holds Oklahoma Medical License No. 9089.
2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That following the taking of testimony on May 18, 1984, the Oklahoma Board of Medical Examiners made no findings but instead requested this case to be continued for the taking of additional evidence at the next Board meeting now scheduled for September 21 and 22, 1984. The Board ordered further that before the next hearing the Defendant should furnish an up-to-date report from her psychiatrist and that the Defendant be available for interviews with the Board or any member thereof upon request.


ORDER

IT IS THEREFORE ORDERED by the Board of Medical examiners of Oklahoma as follows:


1. That this cause be continued for the taking of additional evidence at the next Board meeting presently scheduled for September 21 and 22, 1984.
