FINAL ORDER

This cause came on for hearing before the Oklahoma Board of Medical Examiners en banc on May 18, 1984, and was continued from that date and then re-opened after notice to Defendant on September 22, 1984. Both hearings were held at 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the Rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff and Bill E.D. Williams, Attorney, appeared for the Defendant and the Defendant appeared also in person.

The Board of Medical Examiners en banc heard the testimony and reviewed all exhibits and being fully advised in the premises, the Board of Medical Examiners therefore finds as follows:

FINDINGS OF FACT

1. That Mary Ann Gilliam, M.D., holds Oklahoma Medical License No. 9089.
2. That the Board of Medical Examiners en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the Rules of the Board.
3. That on or around March 9, 1984, the said Defendant, as shown by her conduct on that date, was unable to practice medicine with reasonable skill and safety as a result of either a mental or physical condition. That the Defendant was apprehended by members of the Oklahoma City Police Department on or around that date and was placed in custody at Central State Memorial Hospital, Norman, Oklahoma, and subsequently moved to Baptist Medical Center under the authority of the District Court of Oklahoma County in Case No. PMH-84-114.
4. That subsequently the Defendant came under the care of Dr. Hugh Connor and the Defendant did voluntarily authorize full release of all her medical records to the Board for its review and has submitted reports from Dr. Connor on her present mental condition.
5. That the Defendant's present mental condition is now stabilized and the Defendant is again competent to practice medicine within the State of Oklahoma.

CONCLUSIONS OF LAW

1. That Mary Ann Gilliam, M.D., holding Oklahoma Medical License No. 9089, was for a time in violation of the Oklahoma Medical Practice Act, 59 O.S. 1981, §509, paragraph 16, to-wit:

"16. The inability to practice with reasonable skill and safety to patients by reason of ... or as a result of any mental or physical condition."

2. That after hearing testimony from the Defendant and reviewing her treatment and a report thereof from Dr. Hugh Connor, the Board finds that the Defendant's mental condition has now stabilized and the Defendant is now able to practice medicine within the requirements of the Oklahoma Medical Practice Act, but that the Board should keep continuing jurisdiction over this matter to ensure that the Defendant continues to make regular progress and maintains her stabilized condition.


ORDER

IT IS THEREFORE ORDERED by the Board of Medical Examiners of Oklahoma as follows:

1. That the Defendant, Mary Ann Gilliam, M.D., Oklahoma Medical License No. 9089, be and is hereby placed on probation under the Oklahoma State Board of Medical Examiners for a period of three years, under the following terms and conditions:

- a. Defendant will continue her psychiatric care given by Dr. Hugh Connor, M.D., and shall fulfill all of his treatments of her condition and the Defendant will immediately notify the Oklahoma Board of Medical Examiners in writing in the event that Dr. Connor discharges her as a patient for any reason.
- b. During the period of probation it is required that Dr. Gilliam comply with the Oklahoma Medical Practice Act as interpreted by the Oklahoma State Board of Medical Examiners and that she appear before the Board or its designated representative upon request.
- c. During the period of probation Dr. Gilliam will continue to authorize release of reports of her progress and treatment from Dr. Connor or any other physician who handles her case.
- d. During the period of probation Dr. Gilliam will furnish to the Oklahoma State Board of Medical Examiners all current legal addresses and any change in address in writing.
